Course Description

Title: Domestic Violence Report and Referral Project

Speakers will present on the Domestic Violence Report and Referral (DVRR) Project which was designed to create a seamless bridge between emergency departments, law enforcement, and the Alameda County Family Justice Center (FJC) in Oakland California.

The DVRR is an electronic report interface that combines the DV mandatory report, Danger Assessment, and “warm hand off” to the FJC in one simple step. In the pilot DV education for hospital staff was provided along with a secure web based tool that can be accessed by computer or tablet to the county hospital emergency department /trauma center. In the first-year Alameda County has successfully doubled the number of reports submitted to law enforcement, and increased the number of Emergency Department Domestic Violence patients receiving services from at the Family Justice Center from 4% to 47%.

The DVRR tool was developed with a grant from the Blue Shield California Foundation with the goals of 1) Simplifying the mandatory reporting process for health care providers; 2) Standardizing the data collected in the reports and improving the forensic value of the report by including images; 3) Creating a direct referral to the FJC (with patient consent) by providing the navigators with safe contact information to call the patient directly.




Domestic Violence Report and Referral (DVRR)

A new way to report DV, assess future lethality, and facilitate follow-up services for victims in Alameda County



Domestic Violence Report and Referral

- Conceptualized in 2005 with the opening of ACFJC
- Supported by the District Attorney, the police chiefs, and the DV advocacy community
- Informed by data from the Alameda County DV Fatality Review Team (1996)
- Recognizing that the DV victims at highest risk of fatality were being seen in the ED's and there needed to be better communication between ED's, advocacy and law enforcement

Domestic Violence Fatality

1 in 5 women killed by their intimate partner received emergency department care in the year prior to their murder for injuries inflicted by the same partner

For every one femicide, there are approximately 9 attempted femicides

(Sharps, Koziol-McLain, Campbell et al 2001)

Problems

- No standardized reporting form
- Reporting process too complicated
- No comprehensive training or protocol
- No current list of active DV advocacy resources
- No standardized response from LE

Opportunities

- Opening of the ACFJC
- The transitioning to the Electronic Medical Record
- The chance to improve quality, compliance and potentially capture VOC

- Provide warm handoff to advocacy with feedback to providers

- Aggregated data collected in analyzable format
 - ➔ PHASE I - Proof of Concept
 - ➔ PHASE II - Complete Pilot for HGH ED
 - ➔ PHASE III - Include All ED's (8 ED's total)

Blue Shield California Foundation Grant to the ACFJC

- Develop DVRR Interface
- Develop multidisciplinary training modules (E-learning)
- Deploy training + DVRR
- Refine interface/validate the form
- Deploy in ED's across Alameda County (8)

IPV Intervention

Creating Sustainable System Level Program

- Identify the Champions (IPV experts on the clinical staff)
- Training -Staff Saturation (all levels of staff gets DV training)
- Policy supported by Leadership and Procedures/ Responses that include community based organizations
- Continuous Quality Improvement- chart review, feedback to providers and regular updates
- Primary prevention efforts- Posters/ signage, pamphlets and information

The History of DV Mandatory Reporting Laws

- Written into California law in 1994
- Added DV to the existing list of mandatory reports which included:
 - ➔ Assault (GSW/Stab wounds)
 - ➔ Physical and sexual abuse of children/sexual exploitation (HEAT)
 - ➔ Elder/dependent adult abuse
 - ➔ Adult sexual assault

Report Requirements

(CA Penal Code 11160-11163.6)

- Who is included in the definition of DV?
 - ➔ Current or past intimate partners
 - ➔ Individuals with children in common
 - ➔ adult family members or individuals that share a home
- What information is included?
 - ➔ Name and whereabouts of the victim
 - ➔ Location and time of the assault
 - ➔ Nature of the injuries
 - ➔ Name of the suspected or reported perpetrator

Report Requirements

(CA Penal Code 11160-11163.6)

DV In Alameda County (pre DVRR)

- DV rate - 4 per population of 1000
- In 2013 we had 14 deaths
- In 2013 155 DV mandatory reports were completed in the AHS Highland ED
 - ➔ 34 (22%) were considered severe (attempted homicide)
 - ➔ Only 45 (29%) were submitted to police within 72hr
- Less than 4% of the patients referred (given phone number) from the ED presented to the FJC for services








DVFRT Death by Gender

Female 53% Males 47%




DV Fatality Review Method of Homicide

Danger Assessment Lethality Risk Factors

- ➔ Used or threatened with a weapon (20.2x)
- ➔ Threatened to kill (14.9x)
- ➔ Prior attempts to strangle (9.9x)
- ➔ Forced sex (7.6x)
- ➔ Weapon present in home (6.1x)
- ➔ Escalating severity of violence over time (5.2x)
- ➔ Partner controls daily activity (5.1x)

DVRR

Impact on the ACFJC

- 236 Patients consented to referral to ACFJC
 - ➔ 107 pts contacted (45%)
 - ➔ 75 receiving services
 - ➔ 32 reached and declined services
- 126 Patients unable to contact
 - ➔ 50 no answer/ no response to voice message
 - ➔ 5 no voice mail set up/
 - ➔ 15 wrong number
 - ➔ 7 disconnected number

FJC Navigators perspective

- Impacts

- ➔ Greater client outreach by navigators
- ➔ Increase number of clients
- ➔ New working relationships with hospitals
- ➔ Pt more likely come for services even if the decline on first contact
- ➔ Using Danger Assessment for safety planning and getting a better picture of the overall situation.

- Potential for expanded roles

- ➔ Making direct contact with hospitalized patients

DVRR Impact for LE

- More timely reports
- Significant improvement in the quality of the information provided + pictures
- Better communication between providers & police
- 2014 Charged cases
 - ➔ Felony 363/ Misdemeanor 1,562

Cherri N. Allison, Esq. is the Executive Director of the Alameda County Family Justice Center (ACFJC). Ms. Allison holds a law degree from the University of Santa Clara, School of Law and a bachelor's degree from the University of California at Berkeley. Ms. Allison has more than 13 years of legal nonprofit management experience and 19 years of experience in the field of domestic violence prevention and family law. Prior to her tenure at ACFJC, Ms. Allison was the Executive Director of the Family Violence Law Center. In addition to Ms. Allison's expertise in nonprofit management, she has extensive experience in board and organizational development, program development, grant writing and investments. In 2007 and 2009 she co-authored Domestic Violence Remedies in California Law Cases, published by the Continuing Education of the Bar. In 2012 she authored a chapter entitled Traditional Response to Domestic Violence: Criminal and Civil Legal Systems in the United States, published in Violence and Abuse in Society: Understanding a Global Crisis: ABC-CLIO; 2012.

Ms. Allison currently serves on the boards of California Women Lawyers, ACLU of Northern California and is the ACLU-NC National Board representative. She is also a member of the Charles Houston Bar Association and the Alameda County Bar Association, and a member and past board president of the Women Lawyers of Alameda County. She currently serves as a member of the Domestic Violence Program Advisory Council, Office of Emergency Management and she a member of the American Bar Association Commission on Domestic and Sexual Violence as well as the Judicial Council of California Access and Fairness Advisory Committee. In 2011 she was selected to serve on the Judicial Council of California Access and Fairness Advisory Committee.

Throughout her career she has been a pioneer in the domestic violence field. For example, working with the Women's Policy Institute, she drafted legislation that would have prohibited the shackling of incarcerated expectant mothers. Though vetoed by the Governor, this legislation recognized the shackling as a form of violence against incarcerated women – a population with a high percentage of women who have experienced domestic violence. Because of her pioneering work, she was inducted in 2009 into the Alameda County Commission on the Status of Women's Hall of Fame in the Justice category, which honors women

who have reformed and expanded legal advocacy in our justice system and in 2010 she was honored by the Santa Clara Law School Center for Social Justice and Public Service.

Hillary Larkin is a Physician Assistant that has worked in Emergency Medicine for the last 23 years. She trained at the University of Wisconsin, and did post graduate training in Emergency Medicine at Los Angeles County- USC. She began working at Highland Hospital an inner city Level II Trauma Center, in the Oakland, California in 1989. Her career in Emergency Medicine quickly expanded to include forensic medicine and the treatment of victims of interpersonal violence. Ms Larkin has develop the Sexual Assault Response Team in Alameda County, which now does 250 exam annually with 13 specially trained midlevel practitioners, who are not only providing state of the art care for victims, but are actively involved in research. Ms. Larkin has developed protocols for medical response the DV in the emergency departments across Alameda County in conjunction with the Alameda county Family Justice Center.
